Effective January 1, 2026, the Boilermakers Lodge No. 191 Benefit Plan will be hosted by the Boilermakers' National Health Plan (Canada). This letter details what the change means for you.

Your Benefit Plan

Your Benefit Plan coverage will not change. You are still a member of the Boilermakers Lodge No. 191 Benefit Plan. On January 1, 2026, your Plan will be considered a division of the Boilermakers' National Health Plan (Canada).

Submitting Claims - New Provider

Effective January 1, 2026, you will submit your claims to GreenShield Canada. Your new benefit card is included with this letter. You and your service providers can submit claims using your current benefit card until December 31, 2025.

Any claims not submitted by December 31, 2025, must be submitted to GreenShield Canada. **For claims incurred prior to January 1, 2026, you have until April 1, 2026, to submit them to GreenShield.**

How to Submit a Claim on/after January 1, 2026

Your health service providers should submit claims on your behalf at the time of payment. **You will need to show your providers your new benefit card.** Instructions on setting up your account are included with your card.

Prior Authorization

You will need to submit supporting documentation for new services that require prior authorization and have not already been approved. This process will be outlined on the Plan website on January 1st. McAteer will provide the assistance you need. **If you have received prior authorization for drugs or services you already use, you do not need to go through the process again.**

Additional Benefit Plan Services

You will be covered for the same additional benefits as you are now. As of January 1, 2026, the Boilermakers' National Health Plan (Canada) will deliver some of those services to you.

Services delivered to you **by your Boilermakers Lodge No. 191 Benefit Plan that are not changing**

- TELUS Health Employee and Family Assistance Program (EFAP)
- Accidental Death and Dismemberment
- Disability Benefits
- Life Insurance

Services delivered to you **by the Boilermakers' National Health Plan (Canada), effective January 1, 2026**

- Out of Province Emergency Medical Assistance
 - Members and Dependants will have a new group number to use. Ongoing claims will not need to be submitted again.
